## FROM THE MINYAN STEERING COMMITTEE --Robert Braun

A meeting of the Library Minyan Steering Committee was held on April 7, 1991 at the home of Sandra and Robert Braun. The following is a brief summary of the meeting.

#### <u>Liaison to Executive</u> <u>Committee</u>

Bob announced Braun that the Temple Beth Am Executive Committee had proposed amending the Temple Bylaws to include, among other things, Library Minyan Liaison as a member of the Executive Committee. The Steering Committee recommended that, in accord with the Minyan Bylaws, a Liaison should be elected by the Minyan as a whole. accompanying article in edition of Minyan Monthly describes the election process and the duties of the Liaison.

### SCHEDULING EVENTS AT THE MINYAN --Lida Baker

On the last page of each Minyan Monthly there is a list of people who are in charge of various Minyan functions. The last item on the list reads "Scheduling Events - Master Calendar," and my name and phone number are given. This means that anyone planning an event at the Minyan should call me first and find out whether anything else is scheduled for the same day.

The decision to put me in charge of the master calendar was made at a Minyan Executive Committee meeting several months ago, but very few people seem to be aware of the proper procedure for scheduling an event at the Minyan. For future reference, here are the steps you should follow:

Should lollow.

Step 1. Contact me and ask me to put your event on the Minyan calendar. At the same time, arrange Torah/Haftorah readings for your event with me.

Step 2. Call the synagogue and ask them to put your event on the synagogue calendar. If you want to have a kiddush in one of the large synagogue rooms, arrange it with them.

Step 3. If you want to sponsor a kiddush for the Minyan, call Elke Tenner.

Step 4. If you want to arrange for a drash in the Minyan, call Julia Arango.

Step 5. If you want to arrange to participate in the service in a way not listed above, contact one of the gabbais (Michael Beals, Alan Broidy, Sharon Kushner or David Wolpe).

#### LIBRARY MINYAN ELECTIONS

The Bylaws of the Library Minyan provide that the Minyan will each year elect an individual to act as liaison to the Temple Beth Am Executive Committee. This role has been filled by unelected individuals since the inception of the Minyan. At its April 7th meeting, the Library Minyan Steering Committee determined to hold elections in June to select an individual to serve as liaison to the Temple Beth Am Executive Committee and to act as Chairperson of the Steering Committee.

The Steering Committee is soliciting nominations for this position. The following guidelines describe the position, qualifications and method of nomination.

#### Description of the Position

The individual chosen as Liaison to the Executive Committee (the "Liaison") will serve in that position until his or her successor is duly elected and qualified. The Liaison will be obligated to serve as a member of the Temple Beth Am Executive Committee. This obligation includes regular attendance at monthly meetings, attendance at meetings of the Board of Trustees, and periodic other service on behalf of Temple Beth Am.

The Liaison serves as the primary person through whom the elected, lay and professional staff of Temple Beth Am convey requests and opinions to the Steering Committee and the Minyan as a whole. As an example, decisions as to the holding of joint services are typically made through (but not by) the Liaison. The Liaison must therefore exercise a of certain discretion amount concerning whether a matter can be decided by the Liaison alone, with the aid of the Steering Committee or by the entire Minyan Membership.

As Chairperson of the Library Minyan Steering Committee, the Liaison coordinates the various standing and special committees of the Library Minyan and calls and chairs Steering Committee meetings when and as needed. The Liaison also coordinates requests for information and action to the Temple Beth Am leadership and staff.

#### Qualifications

The Liaison must be a member in good standing of the Library Minyan. As such, that person must be current in all dues obligations to Temple Beth Am, must regularly attend the Library Minyan and must contribute to the functioning of the Library Minyan through service, e.g., by participation in child care, davening or other activities.

The Liaison must be prepared to devote the requisite amount of time necessary to fulfill the functions described above. Attendance at Executive Committee and Board of Trustee meetings requires a commitment of approximately 4 hours monthly, plus the time necessary to prepare for those meetings. The Liaison should probably expect to spend an equivalent amount of time, outside of attending Minyan services, in fulfilling his or her duties.

#### Nominations

Nominations may be made either by or on behalf of a nominee by advising Robert Braun in writing. Each nominee, by agreeing to allow their name to be placed for election, agrees to commit t fulfill, to the best of his or her ability, the obligations of the Liaison and represents that he or she is not subject to any limitation which would prevent that person from fulfilling these duties.

Nominations should be submitted no later than May 15, 1991. Nominations will be made public in (continued on page 6)

#### STEERING COMMITTEE--Continued

High Holiday Services/Membership

The Committee then discussed High Holiday Services. Lida Baker offered to serve on the High Holiday Coordinating Committee, whose offer was gratefully accepted.

There was a heated discussion regarding whether the Minyan should authorize using a microphone at High Holiday services. That discussion evolved into a general discussion of the Minyan's High Holiday Services.

Bob Braun then advised the Committee that he had been asked by the Temple to help prepare a letter to Minyan members who are delinquent in dues, noting that those individuals and their families will not be entitled to benefits of Minyan membership, including High Holiday seating. The Committee approved sending out such a letter.

The Committee spent a great deal time discussing qualifications for entitlement to High Holiday seats. It was recalled that the "official" (and rarely enforced) policy of the Minyan was to limit seating to Library Minyan members and their out-of-town relatives. This was also seen as unfair to those who wished to spend the holidays with their families who were not lucky enough to live outside Los Angeles. The Committee also discussed the fact that despite the Minyan's yearly efforts, nonmembers who had no affiliation with the Minyan seemed to obtain tickets from the Temple.

This issue was not resolved, but it was noted that a more concerted effort should be made this year to determine who are active Library Minyan members for the purpose of determining seating at High Holiday Services.

#### Personal Note from the Chair:

Additional discussion on High Holiday Services will be held at the next Steering Committee meeting, which will probably be held after Shavuot. Personally, and after some consultation with my unnamed (and unknowing) advisors, it may be time to review and possibly revise our High Holiday policies, including seating, use of microphones and other matters. I encourage Minyan members to bend their thoughts to this so that we can come up with some sort of consensus.

#### Other Business

The following additional suggestions were made at the meeting:

- 1. It would be appropriate for someone to hold the Torah during Haftorah reading, and the Minyan will encourage this practice.
- 2. Members should remember that Lida Baker keeps the official Minyan calendar. Lida should be informed if you are planning a special occasion to avoid any timing conflicts.
- 3. If you are planning a special Shabbat or holiday service and expect a large turnout, please advise Stan Goldstein in advance so that we can arrange for additional seats.
- 4. It is apparent that we need a new Torah Scroll. Lida Baker will be looking into the details and financial consequences. Look for details.

## MEMBERSHIP COMMITTEE PROGRESS REPORT --Leon Rogson



#### Elections

Elections will be held by written ballot at the general meeting of the Library Minyan June. The Steering Committee will establish procedure and determine whether individuals may vote by mail or proxy. Only members in good standing in the Minyan (i.e., members who are current in payment of Temple dues, who regularly attend Minyan services and who contribute to the operation of the Minyan) may vote for the Liaison. Persons interested in assisting in this process should contact Robert Braun.
