## ALCOHOL CONSUMPTION ON PURIM

## Dos and Don'ts

An Ad Hoc Committee appointed by the Library Minyan Steering Committee to consider improvements in our Purim and Simchat Torah Services met in January. This committee considered issues relating to excessive drinking, drinking by minors and decorum. The committee members included a teenager, the chair of the ritual committee, parents and longtime minyan members.

It was emphatically not the committees purpose to propose major changes in our services for these two holy days. The consensus was that they are among the best celebrations of these holidays available this side of the Hudson River.

The following suggestions have been adopted by the committee. Library Minyan members are urged to support these minor changes for our safety and enjoyment of the celebrations.

#### ALCOHOLIC BEVERAGES

Alcoholic beverages should be kept in the possession of those who brought them or on one table. Volunteers will be recruited to stay at this table as "bartenders", both to assist those imbibing and to assure that minors are not drinking excessively without the knowledge and consent of their parent(s), and that people who are likely to be driving that evening do not get drunk.

#### ALCOHOL ON THE BIMA AND AMUD

Alcoholic Beverages should generally not be drunk on the Bima or at the Amud (table) used for reading the Torah or the Megillah. At no time is it appropriate to swig hard liquor from a bottle or have bottles of liquor on the Amud or Bima.

#### ALCOHOL AND MINORS

It is not our intention to prevent minors from drinking at all, however, it is parents' responsibility to monitor this sort of activity.

## EMPTY LIQUOR/WINE BOTTLES

Empty bottles should be adequately discarded. Children should not be given empty bottles to "pretend" to drink from, to tie to Tallitot or to refill with water.

#### DRINKING AND DRIVING

We do not want to be responsible for tragic events that result from drinking and driving. Please be sure to have a designated driver if you are planning on consuming alcoholic beverages.

## MINYAN MEETING MINUTES

A regular meeting of the Library Minyan was held to discuss various issues brought to the Steering Committee. The following are the minutes from the October 18, 1998, meeting of the Library Minyan of Temple Beth Am.

\$100 was allocated to Hazzan Lipton's Music Fund as a thank you for his help in providing a microphone for the High Holidays. (see article in this *Minyan Occasionally!*)

### RITUAL COMMITTEE REPORT

The use of the new Siddur Sim Shalom was discussed. Since no one present except Avi Havivi had seen one, the issue was tabled for the Ritual Committee.

The issue of drinking alcoholic beverages in the Chapel during Simchat Torah was raised by Fran Grossman. The group agreed that the Minyan needs to consider the total issue of what is appropriate behavior on Simchat Torah and Purim. Norm Green offered to chair a separate committee to address these issues. (see article in this Minyan Occasionally!)

Avi Havivi proposed that the Minyan consider changing from our current practice of reading Torah according to the triennial cycle to reading the full Torah portion each week. Avi also proposed that the Minyan try this out for a period of time before making a final determination. (see article in this *Minyan Occasionally!*) After a lengthy discussion, the following proposal was negotiated and voted upon: The trial period for a full Kriya would be for a full Sefer and begin with Sefer Shemot. Preceding the trial period would be some discussion in the Minyan probably via D'rashot of the pros and cons of a full Kriya. The Minyan would then vote by mail ballot to decide whether to proceed with the trial period. This vote would need to be by Dec. 20 in order to start the trial with the beginning of Sefer Shemot. The ballot would include dividing the trial period into three parts: no other changes made to the length of the Shabbat service, starting at 9:30 AM, and starting at 9:45 AM with an abbreviated Pesukei D'zimra. The vote on the above proposal was: five (5) in favor, seven (7) opposed.

## UPDATE ON TRIENNIAL VS. FULL TORAH READING

On October 18, 1998, an open meeting of the Library Minyan membership was held. The agenda item that occupied most of the meeting was the question of considering a trial of a full weekly Torah reading rather than our current triennial cycle. After much debate, a motion was made to put a mail vote of the entire Minyan membership, the question of whether or not to adopt a full weekly Torah reading this year for the book of Exodus (approximately 2 1/2 months). With the following changes made to assess mor fully the impact

this would have on the pacing of our Shabbat morning service: For the first third of Exodus, no change in the service other than doing the full Torah reading; for the second third of Exodus, starting services 15 minutes earlier (9:30); and for the last third, doing an abbreviated version of Pesukei D'zimra. The intent of the motion was to give the Minyan membership the opportunity to decide if it wanted to try out a full Torah reading on a limited experimental basis, and to experience different ways of how this might impact on the timing and pacing
